- SHAC Updates
 - REACH Update

 - IMPACT Waxahachie Update

 - WISD Security Update
 - Mental health crisis is still prevalent right now – feel that there is a need for more resources – psychiatric hospitals are full so it is harder for students to get the help that is needed
 - WISD Health Update
 - COVID is currently going great – only have 3 cases within the district at the time of the meeting and they are all siblings
 - Drug testing at the junior high level is now complete for the school year – March results showed no positive results and we have not received the results from April yet; testing for the high school campuses that was to take place in April was moved to May due to state testing on the campuses

- 2021-22 SHAC Sub Committees
 - Coordinated School Health Program Presentation – Members heard presentation from Bryan Austin with CATCH Global Foundation regarding their program and options for curriculum
 - Child Abuse, Family Violence, Dating Violence and Sex Trafficking Update – this subcommittee met on March 23 to hear presentations given by Love 146’s Not a Number and the Monique Burr Foundation regarding curricula that each organization had to offer for this topic – committee felt that one organization has curriculum that covers all topics needed more than the other organization

 - Melissa Bousquet made a motion to continue usage of “Choosing the Best” curriculum materials related to human sexuality instruction with a second from Martha Cunningham, and the motion passed unanimously.
