SHAC Updates

- REACH Council Update
 - Prom Pop-Up event will take place at the Waxahachie Civic Center February 26-27, 2024 from 4-8
 pm REACH is now accepting new and gently used dresses and suits also looking for volunteers to help work the event
 - Rescheduling of Tall Cop to Feb. 23 and finalizing the venue speaker who presents on current trends of drug and tobacco use
 - REACH also gives presentations on Fentanyl awareness training if anyone is interested for their school or organization

• Counseling Update

- Mid-year reports:
 - Care Solace for families of students and employees seeking mental health care from Sept. 1 – Jan. 18 there have been 41 cases accepted and services found from 2,641 total communications received by the company – there have been 45 total anonymous searches – this has saved 64 hours of work for district counselors
 - Mind Above Matter currently have 10 students in our in-house unit and have a waiting list – services are not offered during the summer – are looking to expand the program next year to include 7-11 year old students
 - Next Step licensed counselors who come into our schools and work with students during the school day – from September through November 237 students have been seen with 1,091 counseling sessions held

WISD Security Update

- Vapes are still an issue and are being handled accordingly
- Have had 10 outside building audits and passed them all no entrance was gained from the outside nor were classroom doors that were checked unlocked
- o Feel that we are in a good place right now security wise

• WISD Health Update

 Drug Testing: Had to cancel testing at the junior highs in December due to a conflict in schedules but have had no positive test results at that level – WHS has had 2 marijuana positives with 1 student having a 2nd positive but the quantitative amount decreased so that is considered a negative for that student

- Community Involvement Update
 - Adopt-A-Class programs sent out a survey and responses received were positive from both the adopters and adoptees & will follow up on those that were not positive
 - Go Van Gogh taking place on campuses February, March, and April looking for volunteers to work along with the junior service league
 - DEAR Day taking place March 8, 2024 at 8:45 AM and 10:15 AM working on a sign up sheet to send out within the next week to 10 days

SHAC Presentations

- WISD Nursing Peer Review Process formation of a sub-committee to review/revise toileting guidelines – Melissa Bousquet presented to the group why a sub-committee had recently been formed due to a concern raised by a parent – there was no fault found by the sub-committee regarding the concern but was found that the toileting guidelines need to be reviewed and possibly revised – determined a committee will be formed to review and possibly revise toileting guidelines; sign up sheet to be on the committee was made available

 - Sub-committee has met 3 times successfully and been able to make changes and/or updates to the current plan which will be brought back to the SHAC committee for approval at hopefully the next meeting on February 29, 2024
